# **REPORT OF LIBRARY DIRECTOR (Informational)**

2. Presentation of the report of the Library Director

Library Director Weed-Brown thanked Vice-President Deal for her service to the Glendora Library.

Weed-Brown informed the Board that six applications were received for the Library Board position. Applicant interviews are scheduled for June 25 starting at 5:30 p.m. The appointment will be made by City Council at the regular City Council meeting following the interviews.

Library Director Weed-Brown reported that 1,223 children were registered for Summer Reading Club as of Saturday, June 15, 2013. These children reported on 1,641 hours of reading. 362 teens reported on 74,182 pages read. 115 Young Adults reported on 19,000 pages read. In 2 weeks staff has issued 310 new library cards and checked out over 17,000 items. The off-site Summer Reading Program is also very successful, with approximately 115 children participating. Weed-Brown added that attendance at the first big Summer Reading program was excellent, with over 300 people at the first show and over 200 at the second show.

Library Director Weed-Brown stated that the new café tables and chairs in the lobby and the teen area are being well used.

In response to a question regarding the historical photos, Weed-Brown replied that the Library received these photos several years ago. New frames will be purchased in the new fiscal year and the photos will be displayed throughout the library.

The Trustees commented on how much bigger and open the remodeled lobby feels.

# **UNFINISHED BUSINESS**

3. Library Plan of Service Goal

The Trustees and Weed-Brown reviewed and discussed the draft strategic plan included in the Board packet. Library Director Weed-Brown pointed out several key segments, such as a more centralized service model, the expanded use of social media and connecting to the CENIC broadband backbone, once approved by the State.

Library Director Weed-Brown reported that a copy of the draft strategic plan was also provided to the City Manager.

The Trustees expressed their support for the draft document as presented. Library Director Weed-Brown stated that she will work on finalizing the document.

4. Planning for Annual Joint meeting with City Council

Library Director Weed-Brown stated that a response has not been received yet regarding the request to schedule the joint meeting for August 13, 2013. She added that the library's strategic plan facilitator, Joan Frye Williams, has tentatively reserved August 13, 2013 to present the process and the results of the Library's strategic plan to City Council.

5. Self-Evaluation of Board of Library Trustees

President Gomer handed out the draft self-evaluation of the Library Board. The Trustees reviewed and discussed the handout.

Library Director Weed-Brown stated that the Friends Foundation quarterly meeting is scheduled for June 25, 2013. Trustee Hollanders stated he would be unable to attend the quarterly meeting. Vice-President Deal stated she would be attending.

Library Director Weed-Brown pointed out the Youth Volunteer Recognition Event scheduled for July 29 at 3 p.m. She asked the Trustees to let staff know if they are able to attend.

The Board reviewed the agenda planning calendar. Library Director Weed-Brown asked the Trustees to let her know if there is anything they would like to add.
